

Instacart Holiday Giveaway

Official Rules

December 7, 2024

- This RaiseRight™ promotion (“Giveaway”) is offered for seven (7) days starting Saturday, December 7, 2024, at 12 am ET through Friday, December 13, 2024, at 11:59 pm ET (the “Promotion Period”).
- Prizes will be awarded to ten (10) RaiseRight registered participants after the Promotion Period is over. One (1) grand prize winner and nine (9) runner-up winners. Only one (1) prize will be awarded per person and per household.
- Enter the Giveaway during the Promotion Period by placing an individual participant order of at least \$100 in Instacart gift cards from RaiseRight. Physical gift cards and eGift cards are eligible toward the order total. Participants will receive one (1) entry per \$100 spent in a qualifying order. Gift card purchases made directly with your organization that are not tracked back to an individual participant account and purchases entered by your coordinator are not eligible.
- Participant accounts with a valid email address on their RaiseRight account, in all states, are eligible. To participate, you must be a legal US resident, eighteen (18) years of age or older at the time of entry. RaiseRight employees and their family members are excluded from the Giveaway.

- One (1) grand prize winner will receive one (1) \$100 Instacart eGift card and one (1) \$99 Instacart+ eGift card (to be redeemed for 1-year Instacart+ subscription). Nine (9) runner-up winners will receive one (1) \$50 Instacart eGift card and one (1) \$59 Instacart+ eGift card (to be redeemed for 6-month Instacart+ subscription).
- Prizes cannot be transferred, redeemed for cash, or substituted by the winner. Prizes will not be

delivered until the order is submitted and closed.

- Winners will be notified by email to the email address on their RaiseRight account, no later than seven (7) days after the end of the Promotion Period. We must have a valid participant account for the selected winner. The selected winner must accept a prize by email as directed by RaiseRight within seven (7) days of notification. Any winner notification not responded to or returned as undeliverable may result in prize forfeiture.
