

## Mother's Day 2024 Giveaway

## **Official Rules**

April 20, 2024

- This RaiseRight™ promotion ("Giveaway") is offered for fourteen (14) days starting Saturday, April 20, 2024, at 12 a.m. ET through Friday, May 3, 2024, at 11:59 p.m. ET (the "Promotion Period").
- Prizes will be awarded to two (2) RaiseRight registered participants after the Promotion Period is over. Only one (1) prize will be awarded per person and per household.
- Enter the Giveaway during the Promotion Period by placing an individual participant order of at least \$25 in Ulta Beauty or 1-800-Flowers gift cards from RaiseRight.
